

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.spottedbowtravelco.com and Spotted Bow Travel Company, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Spotted Bow Travel Company, LLC include www.spottedbowtravelco.com and Spotted Bow Travel. The Spotted Bow Travel website is a travel agency site. By using the Spotted Bow Travel website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Spotted Bow Travel may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Spotted Bow Travel collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Spotted Bow Travel may also use your personally identifiable information to inform you of other products or services available from Spotted Bow Travel and its affiliates.

Sharing Information with Third Parties

Spotted Bow Travel does not sell, rent or lease its customer lists to third parties.

Spotted Bow Travel may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Spotted Bow Travel may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Spotted Bow Travel, and they are required to maintain the confidentiality of your information.

Spotted Bow Travel may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Spotted Bow Travel or the site; (b) protect and defend the rights or property of Spotted Bow Travel; and/or (c) act under exigent circumstances to protect the personal safety of users of Spotted Bow Travel, or the public.

Tracking User Behavior

Spotted Bow Travel may keep track of the websites and pages our users visit within Spotted Bow Travel, in order to determine what Spotted Bow Travel services are the most popular. This data is used to deliver customized content and advertising within Spotted Bow Travel to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Spotted Bow Travel. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Spotted Bow Travel website.

Use of Cookies

The Spotted Bow Travel website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Spotted Bow Travel pages, or register with Spotted Bow Travel site or services, a cookie helps Spotted Bow Travel to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Spotted Bow Travel website, the information you previously provided can be retrieved, so you can easily use the Spotted Bow Travel features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. Children Under Thirteen

From time to time, Spotted Bow Travel may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication.
